

NOTICE OF OPTIONAL REDEMPTION

Notice is hereby given that by order of the Board of Commissioners of Anoka County, Minnesota (the "County"), there has been called for optional redemption and prepayment on

November 15, 2017

(the "Redemption Date") the entire outstanding principal amount of the General Obligation Bonds, Series 2009F, dated December 9, 2009 (the "Series 2009F Bonds"), with the stated maturity dates, in the principal amounts and interest rates, and with the CUSIP numbers set forth below:

The Series 2009F Bonds to be prepaid are subject to redemption at the redemption price of one hundred percent (100%) of the principal amount thereof plus accrued interest to the Redemption Date (the "Redemption Price"). U.S. Bank National Association, as Bond Registrar, shall pay the Redemption Price to The Depository Trust Company in accordance with the provisions of the Letter of Representations. No interest shall accrue on the Series 2009F Bonds subject to redemption and prepayment after November 15, 2017.

In compliance with the Interest and Dividend Tax Compliance Act of 1983 and Broker Reporting Requirements, the County is required to withhold a specified percentage of the principal amount of the redemption price payable to the holder of any Series 2009F Bonds subject to redemption and prepayment on the Redemption Date, unless the County is provided with the Social Security Number or Federal Employer Identification Number of the holder, properly certified. Submission of a fully executed Form W-9, Request for Taxpayer Identification Number and Certification (Rev. December 2014) will satisfy the requirements of this paragraph.

Publication of a notice of redemption of the Series 2009F Bonds is not required by applicable Minnesota law.

The County is not responsible for the selection or use of the CUSIP numbers with respect to the Series 2009F Bonds. The CUSIP numbers in this Notice of Optional Redemption are provided solely for the convenience of the holders of the Series 2009F Bonds and no representation is made by the County as to the accuracy of such CUSIP numbers.
